

## Instruction for the authorisation of Tipos programs and DokaCAD


### Some important hints in advance:

- Please, first check the system requirements, shown on our website. When the condition is not fully satisfied, Doka cannot guarantee for smooth ability and functionality. Caution: The system requirements of each program module are different!
- For DokaCAD you need the appropriate AutoCAD-installation.
- Each program module must be registered separately!
- The authorisation code is only valid for the computer and the program module, from where the registration has been done!

### Authorisation process:

1.)

Call the requested program (Tipos-Doka, Tipos beam statics, ...).  
The following dialogue is opened:



Enter authorisation code

The full version of this product is only available once a valid authorisation code has been entered.

5.)

Within the next working days you will get an e-mail with the authorisation code for the requested module, which you must enter in the dialogue mentioned in point 1.). We recommend entering the authorisation code with Copy / Paste, to avoid type errors.
